Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015, we hereby notify that the operations/productions of our EPS Plant at Chennai have been stopped due to heavy rainfall and subsequent discharge of water from Puzhal reservoir leading to submerging of all the roads of plant and manufacturing complex caused by severe cyclonic storm "Michuang". The expected downtime/damages can be assessed only after the water level recedes. The plant has adequate insurance cover including loss of profit insurance.
